Dear District 2,

On March 16, 2020 the County of Alameda's Health Officer directed all individuals living in Alameda County to shelter at their place of residence from March 17 to April 7, 2020 in response to COVID-19. **Essential businesses and services will remain open during this period.** This means grocery stores, gas stations, and restaurants for take-out orders are just some of the stores that will remain open in addition to local emergency response units, such as fire, police, and ambulance. During this unprecedented step, it is important that we pull together as a community, state, and nation. When faced with serious challenges, our country meets them head-on. To that end, it is important that we remain grounded and take the steps needed to ensure everyone's health. Often during a situation like this, the psychological impacts can be worse than the virus we are attempting to contain. Contained in this email are important informational, best practices, and resources to utilize while we come together to meet this challenge (see lists below).

The Board of Supervisors will maintain its regular calendar and continue to hold essential open public meetings in the Board chambers during this period. We will implement Alameda County Public Health Department approved social distancing requirements, have hand sanitation stations available, and thoroughly disinfect the chambers prior to and after meetings. Maintaining these essential government meetings is critical to ensuring the smooth operation of your county government during this pandemic.

The District 2 Office in Hayward and Oakland will be closed during the shelter in place order. District 2 staff will remain on the job responding to constituent calls and emails during this Order. Please remember to use these best practices:

- Wash your hands often with soap and water for at least 20 seconds especially after you have been in a public place, or after blowing your nose, coughing, or sneezing. If soap and water are not readily available, use a hand sanitizer that contains at least 60% alcohol. Cover all surfaces of your hands and rub them together until they feel dry.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Avoid close contact especially with those who are sick
- When out in public, maintain at least 6 feet of distance between yourself and other people if COVID-19 is spreading in your community. This is especially important for people who are at higher risk of getting very sick.
